Working on a solution to make temp building more permanent, don't have cost yet, east side will be more difficult.

Took tour of new building, looks great, working on little things, paint, asphalt. Final inspection may be next week, after final we can apply for occupancy.

Old Business:

 Amended and Restated Service Plan: The public hearing for the Service Plan on May 23 was attended by David, Eric, Pat, and our attorney Emily. Emily gave an excellent presentation. The Commissioners approved the Service Plan, and it is documented in the May 23, 2024 BoCC meeting minutes.

New Business:

- Ambulance Bays Open House: Eric and David are meeting Pat Hill with the Pikes Peak Courier tomorrow and she will do a story on the bay's dedication and open house. The date for the dedication and open house is on Saturday, July 6, from 11:00 am until 2:00 pm. We will serve hamburgers, hotdogs, potato salad, beans, and potato chips, and probably cookies. The bronze plaque was completed and was picked up yesterday. We have lip balm, pens, and first aid kits for swag to pass out. The red Polo shirts for the Board have been ordered. We will do non-certified stop the bleed and CPR class instruction. Lisa Pitts with Divide Fire will be present with car seat education and demonstrations as well as information for all ages of passengers and drivers. Joining Lisa will be Amanda Abramczyk-Thill from Children's Hospital Colorado Springs. There will be a limited number of bike helmets for distribution to youth who are in need of one. In addition, there will be many bits of information on helping kids to stay safe not only in the summer months, but also throughout the year. UPRAD will have a table promoting their community paramedic program.
- Station Alerting: The Board approved a budget of \$63,581.52 for station alerting in 2022. We received an updated estimate of \$65,137.50 in August 2023. We are reviewing our station alerting plan to see if there should be any changes and will receive the final estimate soon. Eric asked if the Board would approve increasing the station alerting budget to \$70,000. If the estimate comes to over \$70,000, it will be brought to the Board at the next meeting after receiving the updated estimate.

EMS Report

Financials:

- In May EMS had 132 calls, 33 transports, and 2 helicopter transfers. In 2023 there were 133 calls in May.
- Charges billed in May were \$84,849.00. Payments received \$24,102.53. Adjustments made were \$60,507.06.

- Luis continues to work on both websites to meet accessibility requirements that are due on July 1st. He said both websites should be over 90% compliant, and ran a report today but it may take up to 24 hours to receive the report.
- Audit update: The audit is going well and should be completed before the State's deadline. Tammy and Eric have provided everything that the auditors have requested up to today. Lewis, the head auditor, is no longer with skr+co.
- Vitalant held a blood drive at our facility on June 6. There were seven donors, five whole blood donations, two RBC-double red donations, and nine units collected of the goal of 20. There is a potential to save 27 lives saved with the blood collected. There were around 20 donors in September, and it is unknown why the numbers are down.
- Paychex emailed that they followed up with the IRS on our Employee Retention Tax Credits (ERTC), and they said they need additional time for processing because of the backlog of filings.
- Eric is taking a vacation June 26 through July 1. He will take his desktop computer if the audit is not completed.
- Dave Parrott is resigning and wants to get a job driving a shuttle. His position will be eliminated.
- Question from Eric, has the County issued the State backfill money to the District? It should be either \$53,166 or \$36,703.

Remodel Update:

- Station alerting needs installed.
- o The TV Room needs the doors installed.
- The transparent door and wall are in and needs some finish work completed.
- The trim above the flooring needs installed.
- o Dave continues to install ceiling tiles.

Minutes of the Proceedings of The Board of County Commissioners of Teller County, Colorado May 23, 2024

1. 9:16 a.m. Convene in Regular Session:

The Board of County Commissioners of Teller County convened in regular session in the Teller County Centennial Building in Cripple Creek, CO.

Mr. Campbell presided.

Mr. Williams gave the invocation.

Mr. Eric Simonson led the Pledge of Allegiance.

Minutes of Previous Meetings:

Action: Mr. Stone moved, and Mr. Williams seconded, to approve the minutes of the meeting of the Teller County Board of County Commissioners on May 9, 2024, as presented. All Commissioners voted yes.

Accounts Payable:

Action: Mr. Williams moved, and Mr. Stone seconded, that the Board approve the accounts payable run date of May 22, 2024, in the amount of \$786,724.72. All Commissioners voted yes.

Board Reports:

Mr. Stone:

- Update on Senate Bill 24-131 concerning concealed carry in "Sensitive Spaces."
 It passed with amendments to remove some of the original locations within the bill. The bill goes into effect July 1, 2024. The County is drafting an ordinance to exempt County spaces from this bill.
- Attended an event last night for District Attorney Michael Allen and local elected officials supporting his campaign.

Mr. Williams:

 Attended the event for District Attorney Michael Allen and supports his reelection.



- Commented on the disagreements between rural and urban communities in Colorado, including futile water rights.
- Commented on the concerns about water rights and opposition to the City of Aurora's attempt to purchase water rights in the Arkansas River Basin which would directly affect ranches, farms and wildlife.
- Noted that due to the increase of trespassing off trail by tourists visiting "Rita the Troll" in Victor, a fence has been proposed to keep people on the designated trail.
- Announced several Memorial Day events:
 - O American flags will be placed on veterans' graves in local cemeteries.
 - o Florissant event to be held on Saturday at 11:00 a.m. at the Grange. Honor quilts will be presented and there will be a dedication of the Purple Heart Trail through Florissant.
 - o The Veteran of Foreign Wars (VFW) will be handing out poppies on Sunday representing fallen veterans.
 - o A ceremony is being held at the Woodland Park Cemetery at 11:00 a.m.

Mr. Campbell:

- Attended a swearing in ceremony at the Sheriff's office for 15 new officers.
- Attended a job fair presented by the Pikes Peak Workforce Center (PPWFC).
- Attended several political events and Chamber events.
- Recognized the Teller County Department of Health for the Distinguished Service Award from the State Department of Human Services.

Elected Officials Report:

Stephanie Kees, Clerk and Recorder

- Gave an update on the upcoming State Primary Election June 25, 2024
 - o Only Democrats, Republicans and Unaffiliated voters are eligible to vote in a Primary Election. The deadline to affiliate is June 3rd.
 - o Approximately 18,200 ballots will be mailed from Denver on June 3rd. The 24-Hour ballot boxes will open the same day.
 - More information is on the County's website.
- Submitted an article to the newspaper concerning the Clerk's property fraud alerts
 and that notices will be mailed to the original property owner making them aware
 of any activity. An online self-service alert system will be implemented in the
 near future.

Commissioner Williams expressed his faith and confidence in the Clerk and Recorder's office in the upcoming election.

Commissioner Stone commented on the property fraud and encouraged the public to take advantage of the upcoming alert system. Also commented on the election process and recognized the election judges who participate in the elections.



Eric Simonson, County Surveyor

Expressed his gratitude to the Clerk and Recorder's, Treasurer's and Assessor's
offices. He specifically recognized Jessica Wildeman in the Clerk and Recorder's
Office for her service and wished her well in her retirement.

Administrator's Report:

Ross Herzog, County Administrator

- Reminded all that County Offices will be closed on Memorial Day.
- Beginning May 6, the Florissant Park will be closed for renovations. Hayden Park in Divide is available.
- Teller County Veterans Services is currently closed. Call the County's main office 719-689-2988 for assistance.
- Graders are repairing roads. If you see something critical, please contact Public Works at 719-687-8812 or report it on the County's website.
- Code Enforcement Officer is investigating illegal camping and rubbish violations.
- Provided an update on the multi-year efforts to upgrade the facilities at the County fairground, including the grandstand. 4-H kids are working hard.

Commissioner Williams commented on the upgrades at the fairgrounds and 4-H community projects.

Commissioner Campbell reminded us about the 125th anniversary of the County Fair, which is scheduled for July 27-August 4, 2024.


2. Time Reserved for Department Heads: None.

3. Time Reserved for the Public without an Appointment:

KJ Lee, Teller County resident: Commented on the water treatment plant expansion in Divide. He is the vice president of Enova Water and believes they have a strategic development plan for the water treatment plan that would cost less to the County. They are in the process of being approved by the State and that State grants could be available. Administrator Herzog will follow up with him.

Scott Marshall, Cripple Creek resident: Thanked the Commissioners for the information on water rights. He provided an update on his efforts to make liquid oxygen more available in the County and met with Mary Higgins at Public Health to discuss requirements and processes. He will move forward with the process to be a certified provider of liquor oxygen. He also commented on the proposed sale of the Newmont Mine and his concerns about contamination on the mine property.

Commissioner Williams recommended Mr. Marshall speak with the new EMS medical director concerning the liquid oxygen and noted that the Colorado Division of Reclamation,



Mining and Safety (DRM) regulates the mine's environmental issues.

4. CDD: Consider a Resolution approving an amended final plat to adjust the interior lot line between Lot 39 and Lot 40 of Indian Creek No.5.

Presenting: Lucy Caillouet, Planner.

Commissioner Williams thanked Ms. Caillouet for her presentation and thanked the applicants for their patience.

In response to a question from Commissioner Stone, Ms. Caillouet confirmed that a driveway permit is required for the development.

Public Comment: None.

Action: Mr. Williams moved, and Mr. Stone seconded, to approve Resolution No. 05-23-2024(16), a Resolution to approve the amended final plat to adjust the interior lot line between Lot 39 and Lot 40 of Indian Creek No.5. All Commissioners voted yes.

5. BoCC: Public hearing on the Amended and Restated Service Plan for the Southern Teller County Health Services District.

Presenting: Emily Powell, General Counsel for Southern Teller County Health District; David Schoenberger, Board Chairman; Pat Martin, Board Member; and Eric Murray, EMS Director

Ms. Powell presented the request for the Health District to amend its service plan.

Commissioner Williams requested the District look into obtaining liquid oxygen in the County, but this would not be a condition of approval.


In response to questions from Commissioner Campbell, Mr. Murray stated it would take approximately 6 months for the District to complete its needs assessment, they do not have plans for a clinic, and have no intentions of raising the mill levy.

Commissioner Williams requested the results of the assessment be made public upon completion.

Commissioner Stone offered that the Opioid Council has funds available they can apply for through the Medications for Opioid Use Disorders (MOUD) program if they find a need.

Public Comment:

Darrick Clayton, Teller County resident. Mr. Clayton commented on the Amended Service Plan and would like to see more details and services for home healthcare, mental health, and telemedicine. He is concerned about taxes and commented on COVID-19.



Board comments.

David Schoenberger explained that the old nursing home was self-supporting and that the District reduced its mill levy this year from 5.7 mills down to 5.1 mills.

Action: Mr. Stone moved, and Mr. Williams seconded, to **approve** the amended and reinstated Service Plan for the Southern Teller County Health Services District, Teller County, Colorado as presented and as approved by the District's Board of Directors on March 19, 2024. All commissioners voted yes.
